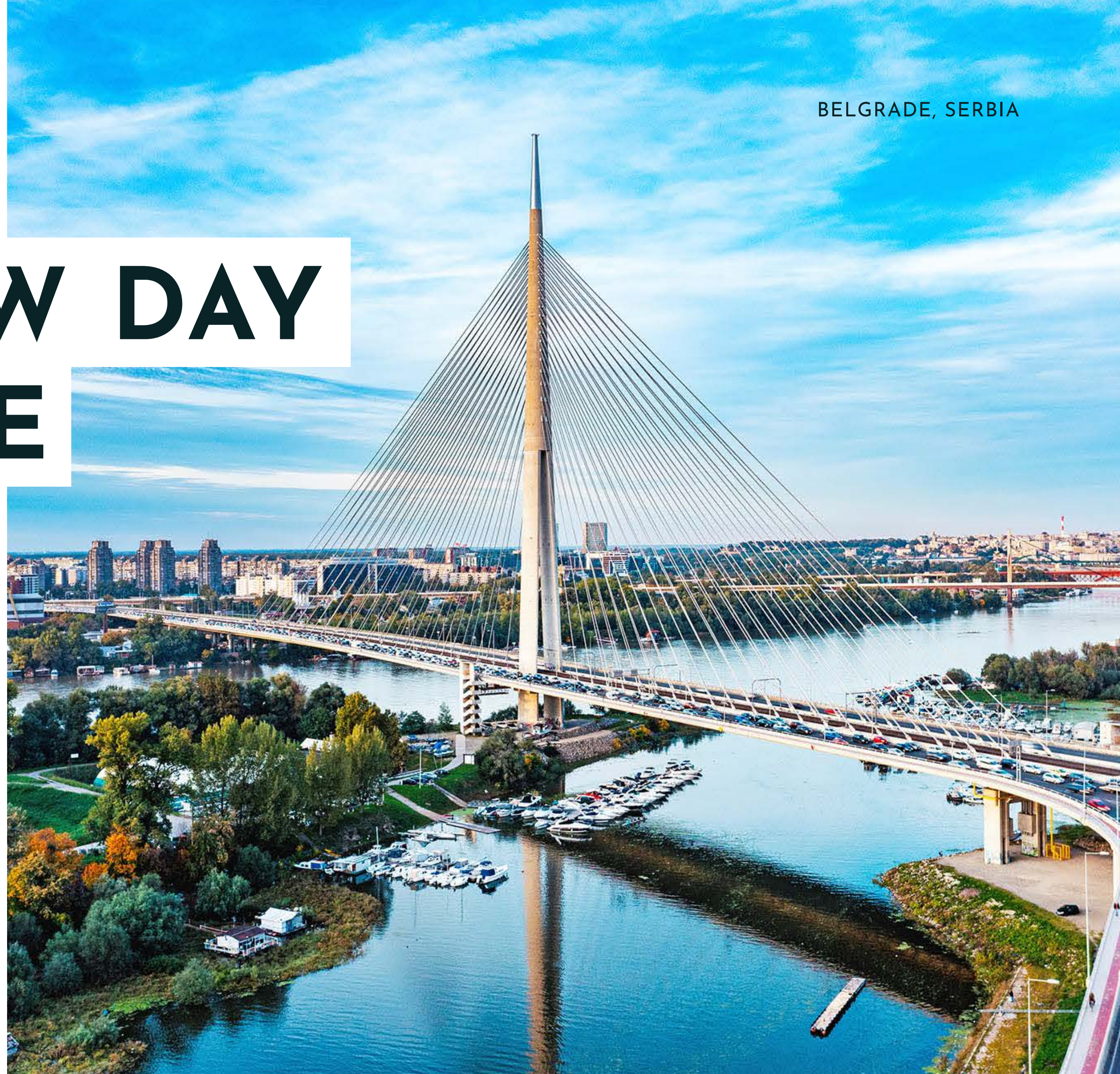

English Law Days highlight the benefits of and latest trends in English law and help to promote English law and the expertise of English solicitors and barristers.

The usual format is for expert panels to discuss the use of English law covering topics such as:

- *methods for avoiding disputes;*
- *international arbitration and dispute resolution;*
- *UK claims involving foreign parties.*

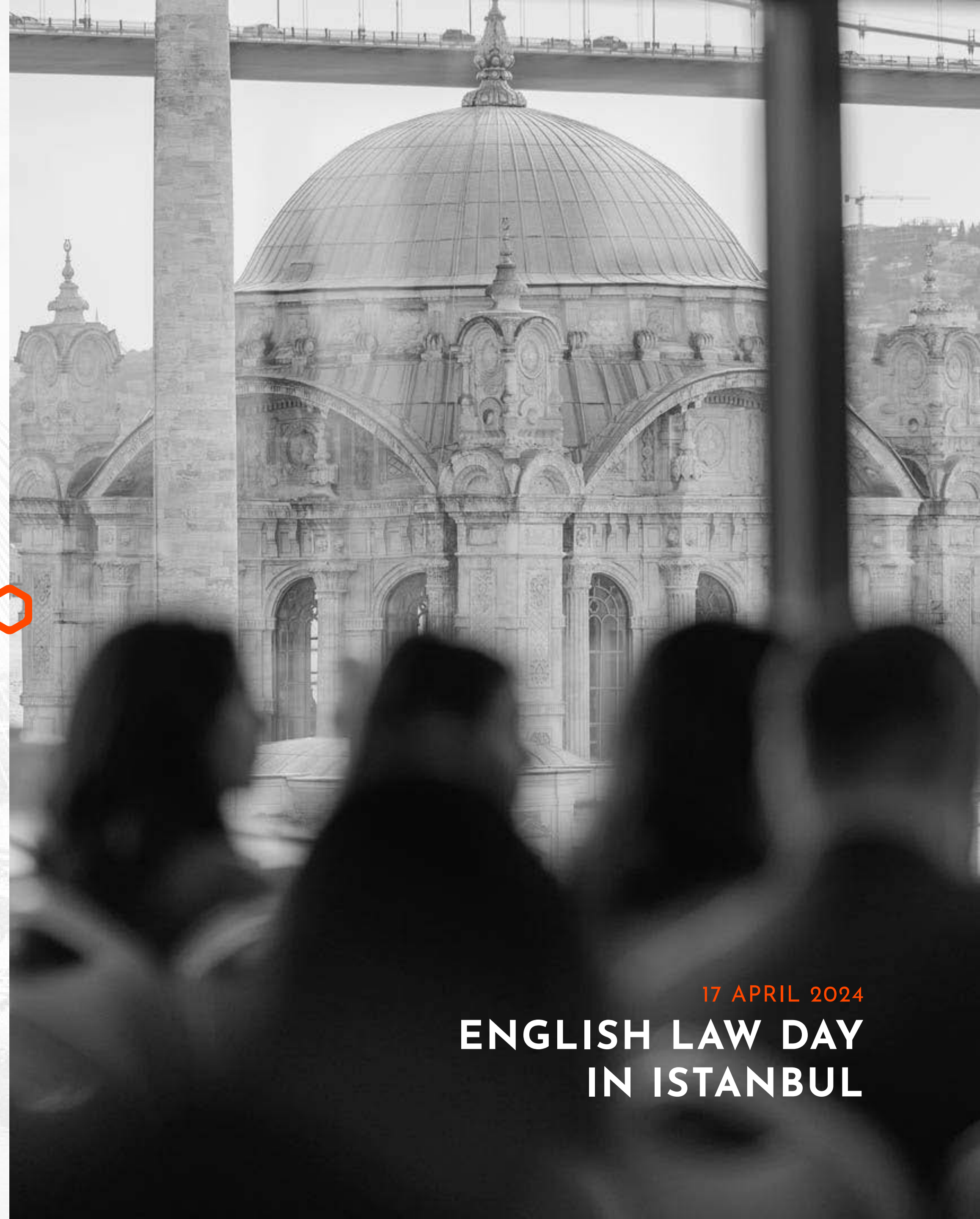


The conferences attract senior representatives and general counsel from leading companies, law firms, financial institutions, advisory firms and organisations from both England and Wales and the host country.
